Financial Aid

Free Application for Federal Student Aid and California Dream Act Application

The state deadline to file the Free Application for Federal Student Aid (FAFSA) form and California Dream Act Application (CADAA) is currently **April 2, 2024**. The CSU encourages students to complete and submit their application as soon as possible.

FAFSA Updates for Students with Contributors without a Social Security Number

Due to recent technical updates, students with contributors without a social security number (SSN) should now be able to successfully submit the FAFSA form according to an <u>announcement</u> made last week by the U.S. Department of Education.

Students in this scenario may still encounter trouble submitting the form, however, a resolution is being worked on. To support students in navigating the FAFSA form and any related issues, the department created a tips document, available in <u>English</u> and <u>Spanish</u>.

Assembly Bill Proposes Financial Aid Deadline Extension

In response to the ongoing submission issues with the 2024-2025 FAFSA form, <u>California Assembly Bill 1887</u> aims to move the current state deadline for financial aid from April 2, 2024, to May 2, 2024. The California State University is in support of this bill. If it passes, the CSU will notify students and counselors accordingly.

CalKids - Free Money for College

CalKIDS is a program from the State of California that funds up to \$1,500 in free money for eligible low-income public school students to save for college and career training. Eligible students who were enrolled in a low-income public school in grades 1-12 during the 2021-2022 academic year can <u>claim their funds</u> and can be used for higher education expenses, such as tuition and related fees, books and required supplies, and computer equipment.
