Admissions

Fall 2024 Admission - Extended Deadlines

Several CSU campuses have extended their application deadlines to December 15 and beyond for transfer applicants. Visit our <u>application dates & deadlines page</u> and use the *"Is Your Campus Still Accepting Applications?"* feature to view open campus programs and their deadlines.

Transfer Academic Update

Fall 2024 transfer applicants will be able to make academic history updates in Cal State Apply starting Friday, January 5, 2024, through Wednesday, January 31, 2024. Applicants will receive an email in early January with more information.

Educational Opportunity Program (EOP) Deadlines

Students who expressed interest and the intention to apply to the <u>Educational</u> <u>Opportunity Program (EOP)</u> in Cal State Apply should check individual campus EOP application and document deadlines on the <u>EOP Admission by Term website</u>. Document deadlines include letter of recommendations.

Reminders and Clarifications

Changes or updates to a submitted application

When a student submits their first application to any campus, regardless of the priority deadline, they will not be able to make any changes to any subsequent application. If students need to report any corrections or updates, please have them <u>contact the</u> <u>campuses</u> they applied to directly.

EOP Recommendation Request Deadlines

If an applicant requests a letter of recommendation for the Educational Opportunity Program (EOP), Cal State Apply will automatically select a default deadline date two weeks from the date the applicant submits the request (e.g., if the recommendation request is submitted on December 1, the EOP deadline date automatically selects December 15). The default date cannot be changed. However, if the default deadline date passes, a recommender will still be able to submit a recommendation. The documents deadline for fall is January 31, 2024 unless noted on the <u>EOP Admission by</u> <u>Term and Deadlines</u> page.

Financial Aid

Free Application for Federal Student Aid and California Dream Act Application

The Free Application for Federal Student Aid (FAFSA) form and California Dream Act Application (CADAA) will open on December 31, 2023. The state deadline to file these applications is April 2, 2024, however, the CSU encourages students to submit by March 2, 2024.
