Re: 2022-23 Student Basic Needs and Graduation Initiative 2025 Budget Allocations

The Budget Act of 2022 includes base General Fund augmentations of \$35 million for Graduation Initiative 2025 and an additional \$10 million for Student Basic Needs. Together, this \$45 million builds upon the estimated \$375 million in base funding allocated for the initiative since 2017-18. Allocations are made to campuses as an Interagency Financial Transaction (IFT) this year, and the amounts will be included in the base budget in 2023-24.

Student Basic Needs

This \$10 million allocation is provided to campuses to sustain and expand Basic Needs initiatives across the CSU. Allocations are based on the campus proportion of students with zero expected family contribution to their total cost of attendance. The funding is to support student outcomes such as persistence and completion by addressing student food and housing insecurity and should augment, and not supplant, other resources. Campuses are strongly encouraged to utilize these new ongoing resources to support campus housing grants augmenting existing financial aid programs. Additional information regarding this model will be provided by the Division of Academic and Student Affairs in a subsequent communication.

Graduation Initiative 2025

Graduation Initiative 2025 is the CSU's ambitious initiative to increase graduation rates for all students, achieve equitable student outcomes, and provide California with a well-prepared workforce.

For 2022-23, \$35 million is allocated to campuses based on the number of students eligible for federal Pell grants in 2020-21. The allocation methodology acknowledges that while all campuses have ambitious graduation rate targets, differing levels of financial investment will be required to ensure equitable student outcomes. Each campus may use the 2022-23 Graduation Initiative 2025 allocation in support of its graduation initiative goals and the newly defined equity priorities that fall within the framework of the six operational pillars. This allocation is to facilitate campus progress toward the established goals and metrics for equitable student outcomes. Progress toward achieving campus goals and the equity priorities will be reviewed during presidents' annual conferences with the Chancellor.
