Re: 2023-24 Support for Students with Disabilities Budget Allocation

The Budget Act of 2023 includes a base General Fund augmentation of \$1 million to support students with disabilities. Allocations are made to campuses as an Interagency Financial Transaction this year and the amount will be included in the final budget allocation memo for 2024-25.

Per the Amended Budget Act of 2023, Assembly Bill 102, this \$1 million allocation is provided to universities to supplement, not supplant, expenditures to improve services to support students with disabilities, with a focus on increasing the number of professional staff serving them. Funds are allocated based on the number of students with disabilities as of fall 2022, with a funding minimum of \$10,000 per university.
