### **INFORMATIVE DIGEST**

These sections are proposed for repeal because Lower-Division Transfer Patterns were rendered obsolete when SB 1440 (Padilla) The Student Transfer Achievement Reform Act (or STAR Act) was signed into law in 2010, creating Associate Degrees for Transfer.
