NOTICE IS HEREBY GIVEN that the Board of Trustees of the California State University proposes to amend:

Section 40050.2 of Article 1, Subchapter 2, Chapter 1, Division 5 of Title 5 of the California Code of Regulations;

Section 40100.1 of Article 2, Subchapter 2, Chapter 1, Division 5 of Title 5 of the California Code of Regulations;

Section 40513 of Article 7, Subchapter 2, Chapter 1, Division 5 of Title 5 of the California Code of Regulations;

Section 40514 of Article 7, Subchapter 2, Chapter 1, Division 5 of Title 5 of the California Code of Regulations; and

Section 41021 of Article 8, Subchapter 3, Chapter 1, Division 5 of Title 5 of the California Code of Regulations.

A public hearing concerning these proposed changes will be held in the Glenn S. Dumke Conference Center at 401 Golden Shore, Long Beach, California 90802-4210 commencing at 9:00 a.m. on May 15, 2018, or as soon thereafter as the business of the Board will permit. 40100.1

40513

Expands previously established DNP degree program scope, allowing post-baccalaureate entry (as well as post-master’s entry) and removing the 2018 pilot sunset date. Updates Education Code sections specified in the “Authority” and “Reference” citations.

40514

Updates Education Code sections specified in the “Authority” and “Reference” citations.

41021

Updates admission requirements to allow post-baccalaureate entry (as well as post-master's entry). Updates Education Code sections specified in the "Authority" and "Reference" citations.
