Ms. McClain recommended adoption of the resolution. A motion was made and seconded. Motion carried.

Chancellor Reed recommended that Dr. Horace Mitchell receive an annual salary of \$220,008 and a housing allowance of \$30,000 effective July 12, 2004, the date of his appointment as President of California State University, Bakersfield. A motion was made and seconded. Motion carried.

Proposed Revision of Title 5 Regulations—Amendment of California State University Conflict of Interest Code

Summary

The California State University Conflict of Interest Code must be updated periodically to reflect changes in the designated positions and disclosure categories of those individuals who make or participate in the making of decisions that foreseeably will have a material effect on personal financial interests. These changes amend Exhibit "A" of Article 20 of Title 5, *California Code of Regulations*.

The Political Reform Act of 1974 requires the Trustees of the California State University (CSU) to adopt a Conflict of Interest Code which requires designated employees to file statements periodically disclosing financial interests which foreseeably would be significantly affected by their making or participating in the making of decisions in their employment with the California State University. This item proposes an amendment of this Code to bring it into conformity with changes made by the campuses and the Chancellor's Office in the titles and responsibilities of designated positions.

As part of the CSU's annual Conflict of Interest filing process, campuses and the Chancellor's Office are asked to review their designated position lists to determine whether the list is complete in scope and accurately reflects current job titles and disclosure categories. This amendment to the CSU's Conflict of Interest Code incorporates the latest campus and Chancellor's Office changes to keep our Code as current as possible. Upon approval by the Board of Trustees, the amendment will be submitted to Fair Political Practices Commission (FPPC) for approval.

Earlier this year the FPPC approved proposed amendments to CSU's Conflict of Interest Code approved by the Board of Trustees in July 2004.

This item satisfies the continuing need to periodically update the designated positions in the CSU. The proposed amendments ensure that the financial interests that must be disclosed are those that are currently involved in the decision-making authority of the designated employees.

Exhibit A to the CSU Conflict of Interest Code contains the designated positions and is the text amended in this action. Exhibit B explains the disclosure categories one through seventeen.

Since changing the CSU Conflict of Interest Code requires an amendment to Title 5 of the *California Code of Regulations*, this item has been noticed for a public hearing as required by law.

Proposed Revision

The following resolution is recommended for adoption:

RESOLVED, By the Board of Trustees of The California State University acting under the authority of Sections 87300 and 87306 of the Government Code and Section 89030.1 of the Education Code, that the Board hereby amends the California State University Conflict of Interest Code in Exhibit "A," "Designated Positions," of Article 20 of Subchapter 7, Chapter 1, Division 5 of Title 5 of the *California Code of Regulations* as specified in Exhibit A to Agenda Item 1 of the July 19-20, 2005, meeting of the Trustees' Committee on University and Faculty Personnel; and be it further

RESOLVED, That the California State University has determined that the amendment of the regulation will not impose a cost or savings on any state agency; will not impose a cost or savings on any local agency or school district that is required to be reimbursed under Section 17561 of the *Government Code*; will not result in any costs or savings in federal funding to the State; and will not impose a mandate on local agencies or school districts; and be it further

RESOLVED, That the Board of Trustees delegates to the Chancellor of The California State University authority to further adopt, amend, or repeal this regulation pursuant to Education Code Section 89030.1 if the further adoption, amendment, or repeal is required and is nonsubstantial or solely grammatical in nature, or sufficiently related to the original text that the public was adequately placed on notice that the change could result from the originally proposed regulatory action.
