# **Approval of Minutes**

The minutes of May 10, 2005, were approved as submitted.

## Naming of an Academic Entity - California State University, Long Beach

Mr. Richard P. West, executive vice chancellor and chief financial officer, presented the item. The item considered naming an endowed center focused on the subcontinent of India at California State University, Long Beach as the Yadunandan Center for Indian Studies, a Solanki Foundation Endowment.

The naming recognizes a \$500,000 endowment created by Uka Solanki, president and chief executive officer of Big Saver Foods, Inc., and his wife, Nalini Solanki. The center's name honors Yadunandan Yadav, Nalini Solanki's great-great grandfather who was known for his leadership and advocacy for education in the northern India

Dr. Robert Maxson, president, California State University, Long Beach noted the center will be dedicated to the impartial study of India's cultures, peoples and history. It will promote India studies through a variety of academic disciplines including the social sciences, humanities, arts and education.

The committee unanimously recommended adoption of the resolution (RIA 07-05-10).

# Naming of a Facility - California State University, Northridge

Mr. West presented the item proposing to name the Student Services Building at California State University, Northridge as Mary and Jack Bayramian Hall. The building will be commonly known as Bayramian Hall.

The naming recognizes a \$7.3 million bequest by Mary and Jack Bayramian to establish the Bayramian Family Scholarship Fund.

Dr. Jolene Koester, president, California State University, Northridge praised the Bayramian family for the extraordinary gift, which is the largest gift from an alumna ever received by California State University, Northridge. She noted that the endowment funds two major new university scholarship programs and faculty development.

The committee unanimously recommended adoption of the resolution (RIA 07-05-11).

The administrator of the Bayramian estate, Mr. Don Barsumian, was present to represent the family. Dr. Charles Reed, chancellor, thanked the Bayramian family for its generosity. Mr. Barsumian said a few kind words on behalf of the family, then Dr. Reed presented him with a framed resolution to commemorate the event.

## Naming of an Academic Entity – San Diego State University

Mr. West introduced the item to name an institute for the study of tribal gaming as the Sycuan Band of the Kumeyaay Nation Institute on Tribal Gaming at San Diego State University.

The naming recognizes a \$5.47 million contribution to the Hospitality and Tourism Management Program at San Diego State University.

Dr. Stephen L. Weber, president, San Diego State University addressed the board noting that the contribution will allow for the creation of a qualified and talented workforce that can address issues impacting tribal gaming. Dr. Weber also recognized the tribe's constant support to the local community and education.

The committee unanimously recommended adoption of the resolution (RIA 07-05-12).

## Naming of a Facility - California State University San Marcos

## **Presentation by:**

### **Summary**

This item will consider naming a new, 3800 square foot building on the campus of California State University, San Marcos as The McMahan House.

This proposal, submitted by California State University, San Marcos meets the criteria and other conditions specified in the Board of Trustees Policy on Naming California State University Facilities and Properties including approval by the system review panel and the campus academic senate.

### **Background**

The proposed naming of the facility recognizes the \$2,353,000 contribution by JoAn and Richard A. McMahan to California State University, San Marcos. The gift will be used to construct and furnish a new facility with private meeting and dining room space designed to accommodate campus and community events, conferences, and Presidential receptions. The facility will support the University in meeting its educational goals through professional and social interaction between members of the campus and the community. The facility will be built entirely with private funds.

Mr. McMahan was the Chief Executive of the family owned McMahan Furniture Company of Carlsbad for over 45 years. McMahan Furniture opened its first store in Bakersfield in 1919, and grew to more than 100 stores in California, Nevada, Arizona, New Mexico and Texas before being sold to East Coast furniture retailer Heilig-Meyers.

The McMahans have consistently and generously supported California State University, San Marcos and are already recognized on the campus within the Kellogg Library through the Richard A. and JoAn S. McMahan Study Room. Their generosity has extended to several other campuses of the California State University.
