The minutes of January 31, 2006 were approved as submitted.

Trustee Foster called the Committee on Collective Bargaining meeting to order and announced the upcoming special teleconference meeting on March 27, 2006 to adopt the CSU initial bargaining proposals for negotiating with three unions, California State University Employees Union (CSUEU), The California Federation of the Union of American Physicians and Dentists (UAPD), and The State Employees Trades Council (SETC).

Then the Committee heard presentations from various union representatives.

Dr. Charles Goetzl, President of Academic Professionals of California, again reported favorably on efforts to implement the new 3-year contract, expressed his desire that parties resolve future disagreements in a constructive manner, and thanked the Labor Relations Managers Sharyn Abernatha, Paul Verellen, and Bill Candella. He also publicly expressed his appreciation of Chancellor Charles Reed's recent initiative to improve the relationships with all CSU unions.

Mr. Pat Gantt, President of CSUEU, and Mr. Dennis Dillon, his colleague, indicated that while they are also encouraged by the recent meeting with Chancellor Reed, they wished to express their concern that the CSU did not formally adopt its initial bargaining proposals at this Committee. The speakers noted that the bargaining on union proposals would begin this week at Dominguez Hills' campus.

Chancellor Reed and Trustee Foster acknowledged the CSU's failure to meet public notice deadline and assured CSUEU that CSU will begin bargaining on its proposals in a constructive manner this week.
