Call to Order

Chair Debra Farar called the meeting to order.

Approval of Minutes

The minutes of January 23, 2007 were approved as submitted.

Chair Farar called the meeting to order and stated there were three agenda items for the Committee.

Chancellor Reed presented a recommendation for Dr. Boice Bowman's compensation as the Interim President of California State University, Dominguez Hills (CSUDH). Due to the short duration of Dr. Bowman's appointment, Chancellor Reed recommended a housing allowance in lieu of residency in the CSUDH Presidential house. Dr. Bowman will also receive a car allowance in the amount of \$1,000 per month and normal executive benefits.

The committee recommended approval of the resolution (RUF 03-07-02).

In accordance with the Board's action in November 2006, requiring informational reports regarding the Executive Transition Program, Chancellor Reed presented a report on the outcome of CSU's negotiation and benefits settlement with newly retired CSUDH President, Dr. James Lyons. Trustee Jeffrey Bleich thanked the Chancellor for his effort in the negotiation and settlement of Dr. Lyon's Executive Transition Program. Trustee Bleich also expressed his appreciation to Dr. Lyons.

Proposed Revision of Title 5 Regulations—Amendment of California State University Conflict of Interest Code

Summary

The California State University Conflict of Interest Code must be updated periodically to reflect changes in the designated positions and disclosure categories of those individuals who make or participate in the making of decisions that foreseeably will have a material effect on personal financial interests. These changes amend Exhibit “A” of Article 20 of Title 5, *California Code of Regulations*.

The Political Reform Act of 1974 requires the Trustees of the California State University (CSU) to adopt a Conflict of Interest Code which requires designated employees to file statements periodically disclosing financial interests which foreseeably would be significantly affected by their making or participating in the making of decisions in their employment with the California State University. This item proposes an amendment of this Code to bring it into conformity with changes made by the campuses and the Chancellor's Office in the titles and responsibilities of designated positions.

As part of the CSU's annual Conflict of Interest filing process, campuses and the Chancellor's Office are asked to review their designated position lists to determine whether the list is complete in scope and accurately reflects current job titles and disclosure categories. This amendment to the CSU's Conflict of Interest Code incorporates the latest campus and Chancellor's Office changes to keep our Code as current as possible. Upon approval by the Board of Trustees, the amendment will be submitted to the Fair Political Practices Commission (FPPC) for approval.

Earlier this year the FPPC approved proposed amendments to CSU's Conflict of Interest Code approved by the Board of Trustees in July 2006.

This item satisfies the continuing need to periodically update the designated positions in the CSU. The proposed amendments ensure that the financial interests that must be disclosed are those that are currently involved in the decision-making authority of the designated employees.

Exhibit A to the CSU Conflict of Interest Code contains the designated positions and is the text amended in this action. Exhibit B explains the disclosure categories one through seventeen.

Since changing the CSU Conflict of Interest Code requires an amendment to Title 5 of the *California Code of Regulations*, this item has been noticed for a public hearing as required by law.

Proposed Revision

The following resolution is recommended for adoption:

RESOLVED, By the Board of Trustees of The California State University acting under the authority of Sections 87300 and 87306 of the Government Code and Section 89030.1 of the Education Code, that the Board hereby amends the California State University Conflict of Interest Code in Exhibit "A," "Designated Positions," of Article 20 of Subchapter 7, Chapter 1, Division 5 of Title 5 of the *California Code of Regulations* as specified in Exhibit A to Agenda Item 1 of the July 10-11, 2007, meeting of the Trustees' Committee on University and Faculty Personnel; and be it further

RESOLVED, That The California State University has determined that the amendment of the regulation will not impose a cost or savings on any state agency; will not impose a cost or savings on any local agency or school district that is required to be reimbursed under Section 17561 of the *Government Code*; will not result in any costs or savings in federal funding to the State; and will not impose a mandate on local agencies or school districts; and be it further

RESOLVED, That the Board of Trustees delegates to the Chancellor of The California State University authority to further adopt, amend, or repeal this regulation pursuant to Education Code Section 89030.1 if the further adoption, amendment, or repeal is required and is nonsubstantial or solely grammatical in nature, or sufficiently related to the original text that the public was adequately placed on notice that the change could result from the originally proposed regulatory action.

For designated employees of a campus of the California State University, "the campus" shall mean the campus of the employees' service. For designated employees in the headquarters office, "the campus" shall mean each campus of the California State University and the Headquarters office or any of all of these.

CATEGORY "6"

Investments and business positions in any business entity or income, including gifts, loans, and travel payments, from any source which is of the type to contract with the campus to purchase agricultural commodities or other products which are sold by the campus. For designated employees of a campus of the California State University, "the campus" shall mean the campus of the employees' service.

CATEGORY "7"

Summary

This item sets compensation for the newly appointed president of California State University, Dominguez Hills.

Background

This item recommends that Dr. Mildred García shall receive an annual salary of \$295,000, effective August 1, 2007, the date of her appointment as president of California State University, Dominguez Hills. Additionally, this item recommends that Dr. García shall be required to occupy the official campus presidential residence located in Carson, California as a condition of her employment as president.

In accord with existing policy, Dr. García will receive the benefits afforded all CSU executives as detailed in the Executive Benefits Summary. For example, provisions are made for the use of a university vehicle or an annual vehicle allowance of \$1,000 per month, vacation and sick leave accruals, health plan programs, insurance programs, and so forth. Additionally, Board policy for a transition program for university presidents will apply provided Dr. García meets the eligibility requirements described in the Trustees' resolution of November 15, 2006.

Recommended Action

The following resolution is recommended for adoption:

RESOLVED, by the Board of Trustees of the California State University, that Dr. Mildred García shall receive a salary set at the annual rate of \$295,000, effective August 1, 2007, the date of her appointment as president of California State University, Dominguez Hills; and be it further,

RESOLVED, that Dr. García shall occupy the official campus presidential residence located in Carson, California as a condition of her employment as president.

Executive Compensation: Individual Transition Program

Summary

At the November 2006 Board of Trustees' meeting, the Trustees adopted a resolution requiring the chancellor to report, when implemented, on new individual transition programs in an open meeting of the Committee on University and Faculty Personnel. This item provides information about the transition of Vice Chancellor Jackie R. McClain from the position of vice chancellor of human resources to the California State University, Chico, campus.

Effective August 1, 2007, Vice Chancellor McClain's title will change to Special Assistant to the Chancellor. From August 1, 2007 to December 31, 2007, she will provide continued assistance with the transition within the Labor Relations' unit and will continue to coordinate the audit of Human Resources functions being conducted by the Bureau of State Audits. As Special Assistant to the Chancellor, Ms. McClain will be appointed as an Administrator IV in the California State University Management Personnel Plan (MPP) assigned to the Chancellor's Office. Ms. McClain will continue to be compensated at her ending salary rate in the position of vice chancellor. Her auto allowance, which is afforded all CSU executives, will terminate on August 1, 2007.

At the conclusion of her temporary appointment as Special Assistant to the Chancellor, Ms. McClain will transfer to the California State University, Chico. The move to the Chico campus will be effective January 1, 2008.
