Trustee Lou Monville called the Committee on Collective Bargaining to order.

## **Approval of Minutes**

The minutes of the May 11, 2010 meeting were approved as submitted.

There was one action item—the ratification of the successor collective bargaining agreement with the Academic Professionals of California (APC) representing the CSU's Student Academic Support Services Professionals in Bargaining Unit 4.

Mary Kay-Statham, president of APC, addressed the committee and expressed the union's appreciation for the CSU's collaborative efforts to reach agreement.

CSUEU President Pat Gantt, Vice President Russell Kilday-Hicks, and Unit 9 Chair Rich McGee voiced their appreciation of the CSU's efforts in mitigating layoffs of employees in their bargaining unit. They also expressed concern about the CSU's budget and reiterated the union's commitment to protect the CSU's funding and bargaining unit jobs.

Trustee Monville adjourned the meeting.
