Naming of a Facility - California Polytechnic State University, San Luis Obispo

Mr. Garrett P. Ashley, vice chancellor university relations and advancement provided background information. The proposed naming recognizes a \$5 million commitment from Leprino Foods, the world's largest producer of mozzarella cheese.

President Armstrong shared information regarding the donor's relationship with the university and the benefits provided by the gift, specifically the creation of an endowed chair in dairy foods who will serve as program director to the new Master's of Professional Studies in Dairy Foods.

RESOLVED, by the Board of Trustees of the California State University, that the Diary Science building, at California Polytechnic State University, San Luis Obispo, be named the Leprino Foods Innovation Institute.

Naming of a Facility—Sonoma State University

Summary

This item will consider naming one venue at the Donald and Maureen Green Music Center at Sonoma State University as the MasterCard Pavilion (or similar name to be mutually agreed upon).

This proposal, submitted by Sonoma State University, meets the criteria and other conditions specified in the Board of Trustees Policy on Naming California State University Facilities, including approval by the system review panel.

Background

The proposed naming recognizes a \$15 million sponsorship by MasterCard Worldwide to Sonoma State University's Green Music Center. This commitment would represent the largest ever sponsorship contributed to Sonoma State University.

The Green Music Center complex, currently nearing completion, allows for the integration of performing arts, particularly in the fields of music and dance. This naming opportunity request is being presented by the University for the outdoor music and performing arts pavilion on the northeast side of the Green Music Center Complex, adjoining the Joan and Sanford I. Weill Hall and located on the Joan and Sanford I. Weill Commons. The pavilion will add to the Green Music Center's versatile performing arts venue arrangement by offering an ideal location for larger outdoor performances. Currently in the planning stages, the pavilion will provide the Green Music Center the ability to book an expanded range of performers.

Weill Hall, Schroeder Recital Hall, the Hospitality Center, the Music Faculty Office Building and the surrounding open spaces at the Green Music Center are considered to be the epitome of academic and performing arts excellence not only for the campus, but for the surrounding region as well.
