Chair Achtenberg called the Committee on Collective Bargaining to order.

### **Approval of Minutes**

The minutes of the July 22, 2014 meeting were approved as submitted.

#### **Ratification of Five Tentative Agreements**

Vice Chancellor Lori Lamb presented the five tentative agreements to the Committee.

# **Public Speakers**

The Committee heard from the following public speakers.

Pat Gantt, President of CSUEU, spoke in favor of ratification of the CSUEU Tentative Agreement. Mike Geck, CSUEU Vice President, indicated strong support among CSUEU membership for ratification. Loretta Seva'aetasi, CSUEU Vice President, supported ratification and urged increase use of in range progressions on individual campuses. CSUEU Chairs Tessy Reese, Mike Chavez, Reggie Keys, Rocky Sanchez, Rich McGee and Susan Smith all urged ratification and thanked the bargaining team members for their efforts. CSUEU Vice President of Representation Alisandra Brewer thanked Chancellor White and the CSUEU and CSU bargaining teams.

Andy Merrifield, Chair, CFA Bargaining Team, noted an improved climate during bargaining and emphasized the importance of maintaining benefits for employees. CFA President Lillian Taiz recognized the willingness of the University to address long term issues like lecturer pay

and faculty workload and indicated there is much more work to be done. She urged campuses to address faculty equity issues.

Prior to the Committee's voting on its action items, Trustee Day expressed his support for ratification of the Tentative Agreements on the Agenda.

#### **Action Items**

The committee then unanimously approved the following:

- 1. Ratification of Tentative Agreement with Bargaining Units 2, 5, 7 & 9 (California State University Employees Union)
- 2. Ratification of Tentative Agreement with Bargaining Unit 4 (Academic Professionals of California)
- 3. Ratification of Tentative Agreement with Bargaining Unit 6 (State Employees Trades Council)
- 4. Ratification of Tentative Agreement with Bargaining Unit 3 (California Faculty Association)
- 5. Ratification of Tentative Agreement with Bargaining Unit 10 (International Union of Operating Engineers)

Chair Achtenberg and Chancellor White expressed their appreciation for the progress made at the bargaining table which resulted in the ratification of each of these Collective Bargaining Agreements.

Chair Achtenberg then adjourned the meeting.
