

MASTER AGREEMENT

THIS AGREEMENT, made and entered into this ____ day of April 2021, in the State of California, by and between the Trustees of the California State University, which is the State of California acting in a higher education capacity, through its duly appointed and acting officer, hereinafter called CSU and

CONTRACTOR'S NAME

Bluebeam, Inc., hereafter called Contractor,

WITNESSETH: That the Contractor for and in consideration of the covenants, conditions, agreements, and stipulation of the University hereinafter expressed, does hereby agree to furnish to the University services and materials as follows:

This Master Agreement for Architectural, Engineering, and Construction Software as a Service, training services, and consulting services to the CSU in accordance with the following Riders and Exhibits, which are hereby incorporated by reference and made part of this Agreement.

Rider A – CSU General Provisions for Service Acquisitions, consisting of ten (10) pages;

Rider B – Supplemental Provisions to CSU General Provisions for Information Technology Acquisitions for Information Security Requirements, consisting of six (6) pages;

Exhibit A – Pricing and Rate Schedules, consisting of five (5) pages;

Exhibit B – Vendor Proposal, consisting of five (5) pages;



Exhibit C – Bluebeam End User License Agreement for Revu software application (the “software”), consisting of twelve (12) pages;

Exhibit D – Bluebeam VPAT Evaluation, consisting of fifteen (15) pages.

The term of this agreement shall be for three (3) years commencing upon the full execution date of this Agreement, and shall continue through, with one (3) three-year renewal option, followed by a one (1) one year renewal option subject to the discretion of CSU, for a total effective period of up to seven (7) years, and upon acceptable Contractor performance. Price increases may be reviewed mutually included at the beginning of each renewal period.

This agreement does not confer an exclusive right to provide Architectural, Engineering, and Construction Software as a Service, training services, and consulting services to the CSU. This agreement may be signed in counterparts, which together constitutes this Agreement, and a signature delivered by electronic means will be considered an original. This agreement may not be amended or modified except by in writing by both Parties hereto.
