- ASCSU representatives to the AAC&U LEAP State Summit in June are Diana Guerin, Mark Van Selst, and John Tarjan.
- Both of our nominees for Faculty Trustee have been interviewed by the Governor's Office.
- Robby Ching and Mark Van Selst from the Smarter Balanced group have volunteered to serve on the Formative Assessment State Leadership Team. Many thanks to them for their service.
- Position description for part-time staff (Sharon's position) has been posted.
- Chancellor White has appointed President Dianne Harrison (Northridge) to Cal State Online Board.
- Executive Committee approved English Council nomination of Roberta Ching (Sacramento) to EPT Committee.
- The first call for information about faculty receiving campus-wide awards in spring 2013 was sent this week, with information due 6/15/13. These faculty colleagues will be highlighted on the CSU system website for the year. The Faculty Spotlight website should launch in fall 2013. Thanks to Faculty Affairs Committee for advice and support on this project.

Update on Legislation

- SB 440 (Padilla) Proposed amendments require CSU to accept all options of degrees. ASCSU testified at the policy committee hearing and worked with CSU Government Relations staff, Chris Mallon, and Nathan Evans on substitute language. We sent a letter of "oppose unless amended" this week.
- SB 520 (Steinberg) Requires public-private partnerships with online vendors.
 ASCSU testified against the bill at the policy committee and sent a letter of "oppose unless amended." SB 520 was amended, but ASCSU still has concerns.
- SB 547 (Block) ASCSU testified in support.
- AB 386 (Levine) ASCSU testified in support.
- AB 387 (Levine) ASCSU testified in support.

Bills are now in Appropriations. Many thanks to FGA committee, Praveen Soni, and Tom Krabacher for ongoing support and advice since the March plenary.
